हिवाळी अधिवेशन केवळ दोन आठवड्यांचे करून सरकारने चर्चा टाळली! : विखे पाटील

मुंबई, दि. १ : दुष्काळासह राज्यातील अनेक समस्यांनी उग्र रूप धारण केले असून, त्यावर विस्तृत चर्चेसाठी विधीमंडळाच्या हिवाळी अधिवेशनाचा कालावधी किमान तीन आठवड्यांचा असायला हवा होता. मात्र ही चर्चा टाळण्यासाठी सरकारने जाणीवपूर्वक अधिवेशन केवळ दोन आठवड्यांचे केल्याचा आरोप विधानसभेतील विरोधी पक्षनेते राधाकृष्ण विखे पाटील यांनी केला आहे.

महाराष्ट्र विधीमंडळाच्या कामकाज सल्लागार समितीची बैठक झाल्यानंतर त्यांनी ही प्रतिक्रिया दिली. ते म्हणाले की, राज्यात दुष्काळाची स्थिती भयावह झाली आहे. दुष्काळ निवारणासाठी सरकारकडून पुरेशी तयारी झालेली नाही. मग तीन दोन आठवड्यांमध्ये हे सरकार दुष्काळी उपाययोजनांनी योग्य अंमलबजावणी करू शकते

नाही, हे महाराष्ट्राने बघितले आहे. त्यामुळे दुष्काळी उपाययोजनांसह शेतकऱ्यांसाठी जाहीर केलेल्या अनेक योजनांच्या अंमलबजावणीत सरकारला आलेले अपयश, मराठा, मुस्लीम, धनगर आदी समाजांच्या आरक्षणाच्या मागणीबाबत सुरू असलेला वेळकाढूपणा, मुंबईचा विकास आराखडा व राज्यातील इतर नागरी समस्यांवर विरोधी पक्षांना समागृहात चर्चा करायची आहे.

त्यासाठी अधिवेशनाचा कालावधी किमान एका आठवड्याने वाढवून तीन आठवड्यांचा करावा, अशी मागणी आम्ही केली. मात्र जनतेचे प्रश्न मांडताना विरोधी पक्ष आक्रमक होऊन सरकार कोंडीत फसण्याची शक्यता लक्षात घेता सरकारने जाणीवपूर्वक अधिवेशनाचा कालावधी वाढवण्यास नकार दिल्याचे विखे म्हणाले.

क्रीडा विकासाची गती मिळणार खेळो इंडिया योजनेची, राज्यात अंमलबजावणी

मुंबई, दि. १ : केंद्र शासनाने सुरू केलेली खेळो इंडिया-क्रीडा विकासाचा राष्ट्रीय कार्यक्रम या योजनेची २०१८-१९ या वर्षापासून राज्यात अंमलबजावणी करण्यास आज झालेल्या मंत्रिमंडळ बैठकीत मान्यता देण्यात आली. या योजनेमुळे राज्याच्या क्रीडा विकासासाठी सुरू असलेल्या प्रयत्नांना मोठ्या प्रमाणात गती मिळणार आहे. या योजनेतर्गत विविध उद्दिष्टे निश्चित करण्यात आली आहेत. त्यामध्ये खेळाच्या मैदानाचा (क्रीडांगण) विकास, सामूहिक (क्रीडा शिक्षकांचे) प्रशिक्षण कार्यक्रम, राज्यस्तरीय खेळो इंडिया केंद्राची स्थापना, खेळाच्या वार्षिक स्पर्धा, प्रतिभावंत खेळाडूंचा शोध आणि विकास (शिष्यवृत्ती), खेळाच्या पायाभूत सुविधांचा वापर आणि निर्मिती-सुधारणा, क्रीडा अकादमीसाठी सहाय्य, ग्रामीण आणि देशी खेळांना प्रोत्साहन स्पर्धा, शाळेतील मुलांची शारीरिक तंदुरुस्ती (तापासणी व मापदंड), महिलांसाठी खेळ-स्पर्धा, दिव्यांगांना खेळाच्या सुविधा व स्पर्धा यांचा समावेश आहे.
