**Women voters outnumber men in Doaba by 6 per cent**

Jalandhar, Punjab, across its three regions of Majha, Malwa and Doaba, has seen a six per cent dip in women voter turnout in this Lok Sabha election compared to 2014.

In Punjab, while 71.11 per cent women voted in the state in 2014, this figure was 65.63 per cent in 2019 elections — a fall of almost 6 per cent. A decade earlier, in 2009, 69.6 per cent women in the state had voted in the general elections. The 2019 figure of women turning out to vote is the lowest in the state since 2009.

However, Doaba this year saw more women voting in comparison to men, making it the only region in the state where women outnumbered men in voting. Nearly 66 per cent women voted against 60 per cent men in four districts (Jalandhar, Hoshiarpur, Kapurthala and Nawanshahr) in 2019, with Nawanshahr district topping the chart. In Majha, around 62 per cent women voted as compared to men around same per cent men. For Malwa, women voter turnout was 66.4 per cent in contrast to men 68.73 per cent in the region.

Overall in the state, 65.63 per cent women voted against 66.26 per cent men in 2019.

Out of 23 Assembly segments in Doaba, 17 fall under two Lok Sabha constituencies and three each fall under Anandpur Sahib and Khadur Sahib LS seats. In 20 of these segments, more women voter cast their votes. In Nawanshahr, all three Assembly segments — Balachour, Banga and Nawanshahr — recorded 70 per cent polling by women against nearly 64% by men. In Hoshiarpur, women voter turnout stood at 65 per cent against 60 per cent polling by men. Kapurthala district saw 64 per cent voting by women against around 58 per cent by men. The figure for Jalandhar was 64.55 per cent women compared to 61.66 per cent men in all nine Assembly segments of the district.

In Majha's four districts — Amritsar, Gurdaspur, Tarn Taran and Pathankot with 25 Assembly segments, 13 witnessed more women voters. Gurdaspur district topped the chart with 71.54 per cent women voters against 67.70 per cent men voters. In Malwa region, barring three Assembly segments, rest 66 segments had less women voters than men.

**Leader of Arun Gawli's Akhil Bharatiya Sena, two others arrested under Arms Act**

Pune. Three persons, including an office-bearer of underworld don Arun Gawli's political party Akhil Bharatiya Sena, have been arrested by the Crime Branch of Pimpri-Chinchwad Police. Police have also recovered two country-made pistols and five live cartridges from their possession.

Police have identified the three accused as Charan Balasahab Thakar (26), Pradip Shivaji Khandge (28) and Raju Shivlal Pardeshi (59). A team of the Crime Branch, led by Senior Police Inspector Uttam Tangade, laid a trap and nabbed Thakar from Kelgaon Road area in Alandi on Tuesday. Police recovered a pistol and a live cartridge from his possession.

An offence was lodged against Thakar at the Alandi police station under sections of the Arms Act. Probe revealed that Thakar had purchased the pistol from Khandge, who was arrested. His interrogation revealed that he had procured two pistols from a firearms dealer from Madhya Pradesh and later sold one to Thakar and another one to Pardeshi. When police arrested Pardeshi, they recovered a pistol and four cartridges from his possession.

A press release issued by the Pimpri Chinchwad Police stated that Thakar, a history-sheeter, was also the Maval taluka president of the Akhil Bharatiya Sena.

**Govt drive to eliminate trachoma**



New Delhi. The Delhi government is all set to launch an awareness programme to eliminate trachoma — a bacterial infection which, if untreated, can cause blindness — by 2020. Trachoma is caused by poor environmental and personal hygiene and inadequate access to water and sanitation.

The number of cases in the capital grew to 1,361 in 2018-19 from 241 in 2017-18. "We hope to bring it down to zero in the capital. It is crucial to create awareness among public and medical professionals. A training programme will be held for doctors on do's and don'ts while performing surgery," said Dr K S Baghotia, additional director, department of health and family welfare.

The department will focus on four categories — surgery, awareness, social wash and environment — to
