In reference to the above, we wish to inform you that the Board of Directors of the Company at its meeting held today (i.e. **July 31, 2023)**, inter alia:

1. Considered and took note of the resignation of the Statutory Auditors of the Company:

Based on the recommendation of the Audit Committee, the Board of Directors of the Company noted and accepted the resignation of M/s Khurdia Jain & Co., Chartered Accountants, FRN: 120263W, who have tendered their resignation vide their letter dated July 26, 2023 informing their inability to continue as the Statutory Auditors of the Company.

The Board and Audit Committee also noted that the Statutory Auditors have not raised any concern or issue and they have also submitted a declaration that there are no other reasons other than mentioned in their resignation letter.

A Copy of Resignation Letter tendered by them along with necessary disclosures as per SEBI Circular no CIR/CFD/CMD1/114/2019 dated October 18, 2019 has already been duly disseminated to the exchange on receipt of the same.

2. Considered and approved the appointment of Statutory Auditors of the Company to fill up the Casual Vacancy in the Office of Statutory Auditor:

Pursuant to Section 139 and other applicable provisions, if any, of the Companies Act, 2013, and based on the recommendation of Audit Committee, the Board of Directors considered and approved appointment of M/s Kothari Jain & Associates, Chartered Accountants, (FRN 113041W) as the Statutory Auditors of the Company, to fill up the Casual Vacancy caused by resignation of erstwhile

auditors, to hold office with effect from **August 1, 2023** till the conclusion of the ensuing AGM of the Company. The said appointment is subject to the approval of the members of the Company at the ensuing AGM.

3. Considered and approved the appointment of the Statutory Auditors of the Company for a period of five years:

Based on the recommendation of Audit Committee, the Board of Directors considered and recommended to the shareholders for its approval at ensuing Annual General Meeting, appointment of M/s Kothari Jain & Associates, Chartered Accountants, (FRN 113041W) as the Statutory Auditors of the Company for a period of 5(five) years i.e. from the conclusion of 34th AGM till the conclusion of 39th AGM of the Company.
